OFFICE ORDER

Subject: Appointment of CEOs of Sector Skill Councils as Joint Apprenticeship Advisers under the Apprenticeship Act, 1961 and delegation of powers – Regarding.

In supersession of Office Order No.MSDE-6(1)/2018-AP dated 18th May, 2018 and in exercise of the powers conferred by Section 27(1) of the Apprenticeship Act, 1961(52 of 1961), the following persons are hereby appointed as Joint Central Apprenticeship Advisers to assist the Central Apprenticeship Adviser and to perform such functions as may be assigned under the Act:

2. The following powers have been delegated to these Joint Central Apprenticeship Advisors [in exercise of the powers conferred by Section 27 and Section 34 of the Act]:

- To approve/register contracts of apprenticeship (contract as per Section 4) for optional trades pertaining to their sectors/qualifications, under the National Apprenticeship Promotion Scheme (NAPS).
- To carry out the activities under apprenticeship training programme including NAPS, as per Section 7(3), Section 8(2), Section 9(2), Section 15(2), Section 30, Section 31 of the Act and as per Rule 11(7), Rule 11(8) and Rule 12(2) of the Apprenticeship Rules, 1992.

3. Their appointment will be subject to the following conditions:

- They will have jurisdiction for skilling activities of concerned Sector Skill Council (SSC) for Optional Trades ;
- Their services will be reviewed periodically after one year;
- Since Joint Apprenticeship Adviser is an ex-officio post of CEO of respective SSC, it will cease as soon as any CEO resigns/is terminated/relinquishes the post; and
- The functions of the Joint Apprenticeship Adviser cannot be further delegated to any other person.

4. This issues with the approval of the competent authority.
