#### EDITORIAL- FROM CEO'S DESK



Dear Partners, Colleagues and Readers,

The second quarter, was a period of stepped up activity for Council in tandem with relative respite on the Pandemic front. This was reflected in all spheres— in interactions with Industry, Associations, Academia, Govt and State govt entities.

The key initiative was formal announcement of Project "AMRIT" in collaboration with German Partner GIZ. Aimed at enhancing and strengthening Platform skills (or ability to better impart skills and training) of in house company trainers, it will have direct involvement of German experts bringing into play cutting edge globally lauded German skilling techniques and methodologies. Huge amount of interest was evident across Industry, including some of the biggest organisations in nominating Trainers for the first lot of 100 planned with GIZ. Content work related to this project has commenced under auspices of GIZ, and project execution is planned for Q3.

LSSSDC had successful events with a number of academic institutions—focused on a range of skilling elements such as career counselling for students, awareness enhancement and updates, MOUs, and launch of new programs. These included career counselling and Apprenticeship webinars with Amity and Chitkara, MOU with Lovely Professional University, and launch of embedded program with MSc Microbiology at CDLU, Haryana. The number of MOUs signed with Universities and colleges under PCI Skill Advancement Partnership continued to grow.

Leveraging its strong Industry connect, webinars were conducted with Team Akums and Tirupati– focused on Apprenticeship/NAPS. A career counselling workshop was organised involving Micro labs, and former Industry experts. Successful Placement drives/ events were conducted with organisations like Lupin and Granules. Alongside, webinars were conducted with Partner Associations such as BDMA.

On the Government front, LSSSDC has proposed to CBSE integration of its qualifications in school programs as voctional subjects. At college level, Council made progress in 'Skill Vigyan Program' with DBT, with further states being brought under the umbrella. A Training Program aimed at increasing employability of youth in Telangana was flagged off, in Partnership with Telangana Academy for Skill and Knowledge (TASK). In Gujrat, funding was secured from Centre for Entrepreneurship Development (CED) Gujrat for conducting assessment and certification of those working in MSMEs. Finally, skilling programs were announced with prominent government institutions such as CSIR and NIPER.

Overall, Q2 marked welcome return to positive zone making up lost territory in Q1, and thus a breakeven for 1H. Riding on these results, there is great optimism in Team LSSSDC for being back on track this year as a self-sustaining Council.

On a more sombre note, LSSSDC lost a highly committed and valued Team member Sachin Sachdeva, who was heading up key functions of Apprenticeship and co-ordination of activity development in key Clusters. Our thoughts and prayers are with his family.

#### COVER STORY: LAUNCH OF PROGRAMME TASK

The State government of Telangana, as part of Hyderabad Pharma City (HPC) project, launched a training programme for youth in villages, especially those situated around the project, to facilitate their employment. The State government, under its commitment to facilitate one job per family that contributed land for the HPC project, is training youth free of cost. Programme is being executed by Telangana Academy for Skill and Knowledge (TASK) in partnership with the Life Science Sector Skill Development.



#### NSQC APPROVAL FOR 3 QUALIFICATIONS

Three (03) rationalized Qualifications were approved in the 12<sup>th</sup> NSQC Meeting held virtually by NCVET on 30<sup>th</sup> Sept 2021:

- Production Machine Operator- Active Pharmaceutical Ingredient (API)/ Bulk Drug, (3 Specializations, v2 (Level 4)
- Production Machine Operator- Non-Sterile Formulation (9 Specializations, v1(Level 4)
- Production Machine Operator- Sterile Formulations (2 Specializations, v1(Level 4)

Committee appreciated LSSSDCs logical and practical approach towards rationalisation of Qualifications. The Chairperson advised that this may be shared by NCVET with other Sector Skill Councils/ Awarding Bodies as "Best Practice" in this regard

#### SCHOOL EDUCTION INTEGRATION INITIATIVE BY LSSSDC

LSSSDC has proposed to CBSE to integrate Life Sciences Qualifications in school programs as voctional subjects starting from 6<sup>th</sup> class, going upto 12<sup>th</sup>. Focus is to keep schools students equipped with awarness, knowledge and foundation skills to enable them to take up career in Life Sciences sector and enhance their carrer opportunities and future prospects.

#### PROPOSAL FOR MSME RPL HAS BEEN APPROVED FOR CED FUNDING IN GUJARAT

Total of 900 numbers have been allocated by Centre for Entrepreneurship Development (CED) Gujrat for completion within current FY. Gujarat based MSME Units will be benefitted with Upskilling and Certification under this project.

Mr Madan shared features of the partnership between LSSSDC and PCI for skill enhancement of B. Pharma students.



- One online TOA program was conducted for Assessor for Store Assistant, and two online TTT programs were conducted for 26 Trainers for 7 QPs




