EDITORIAL- FROM CEO'S DESK



Dear Partners, Colleagues and Readers,

January 14 was a historic day in the relatively short history of the Council. Sri Satish Reddy, Chairman, Dr Reddys Lab, who has been Council's Chairman since inception and contributed immensely to its current recognition as one of the top performing Skills Councils, opted to step down. Our sincere thanks to Sri Satish Reddy for everything. Mr Sudarshan Jain, currently Secretary General of IPA, the Association that represents the top 25 Life Sciences sector companies in India, was elected as Chairman. The Council is indeed fortunate to have had Sri Satish Reddy, Chairman of one of India's largest Pharma companies as its first Chairman, and to have Sri Sudarshan Jain, a seasoned Healthcare and Life Sciences veteran taking over from him. We can say with confidence that the Council has been and remains in finest hands.

After almost 2 years in the red, impacted together with rest of the world by Covid, the Council announced a welcome return to being 'self-sustaining', whilst declaring results for the financial year ending March 31. This is the outcome of resilience, commitment and hard work on part of the entire team of LSSSDC—in a very challenging year. Importantly, the quality of its activity portfolio improved— with each new activity viz 'Project Amrit' (raising quality of in house trainers), Upskilling, and E skilling registering significant revenue streams, and in excess of targets set. The Council aims to build upon these successes.

Project Amrit aimed at raising quality of in house trainers, including those from India's largest and finest Pharma companies, deserves special mention. The target number of 100 trainer registrations was very quickly surpassed, enabling launch of this program involving the reputed German organisation GIZ, and through it integrating German methodology and experts. The program was lauded by participants and initial feedback from across participating organisations has been very positive. The Council wishes to express its thanks to the very capable team of GIZ, and looks to continue building upon the very firm Partnership already existent with this esteemed organisation.

Council's continued success in Apprenticeship is again noteworthy. This year the Council triggered almost 14,500 contracts, surpassing the target of 12,000, and registering an increase of almost 45% over the previous year number of just over 10,000. Most continue to find permanent placement.

After significant success registered with its first Upskilling module—360 degree GMP for Machine Operators which has notched up 2400 licenses, the Council launched another 2 focused on Packaging Assistants and Manufacturing Assistants. All these have been developed with support of GIZ. Council continues to expand the portfolio of users of these modules and going forward plans to, with GIZ help, track feedback from users with view to regular improvements.

COUNCIL REVERTS TO BEING SELF SUSTAINING FOR THE COMPLETED YEAR 21/22

LSSSDC emerged victorious after the Covid hit period, declaring results for year ended March 31, 2022 that again made it self-sustaining. This was despite a very challenging year marred by the Pandemic, and loss of a key team member to Covid. Significantly, new activities such as 'Project Amrit' aimed at raising the quality of Trainers, Upskilling of workforce and E skilling turned in results surpassing targets.

COVER STORY: INDO-GERMAN TRAIN-THE-TRAINER (TTT) PROGRAMME - AMRIT CONCLUDED SUCCESSFULY

LSSSDC successfully completed the first Indo-German Train-The-Trainer (TTT) programme - 'Project Amrit' on 25th February 2022. It is a joint initiative with its German collaboration partner GIZ, (recognised German NGO committed to support Skill development activities in India).

Under the first phase, 117 trainers were trained in four batches through online mode by German Master Trainer – Steffen G. Bayer. These participants were from different industries of reputation like Cipla, Dr. Reddys Laboratories, Emcure Pharmaceuticals, Lupin, Macleods Pharma, Narprod Group, Penam Laboratories, Sun Pharma, USV etc.

Initial feedback from key Partners nominating their trainers for this project has been very positive, and catalyses the way forward for further similar programs. Along with Board members, CEO-LSSSDC Mr. Ranjit Madan, congratulated to Dr Nivedita Murkute, Senior Director-LSSSDC and her team, and expressed sincere thanks to Team GIZ. Phase 2 of AMRIT is expected to be launched during Q1, 2022/23, and may cover Academia too for faculty development.

COVER STORY: LIFE SCIENCES INDUSTRY ENGAGES OVER 14000 APPRENTICES IN FY 21-22 UNDER LSSSDC'S OPTIONAL TRADES

More than 14,500 apprentice contracts have been generated till 31st March 2022, marking an almost 45% rise in apprenticeship engagement since April 1, 2021. We acknowledge the significant contribution made by our previous Director, late Mr. Sachin Sachdeva, to whom we lost in Covid19, with the baton ably being picked up since by Mr. Anshul Saxena, Senior Director-LSSSDC, along with the Cluster Team. In total, since Dec 2018, LSSSDC has facilitated over 33,000 apprentice engagements. Top 5 states are Gujarat, Maharashtra, Telangana, Goa and Himachal Pradesh.

LSSSDC has been creating awareness among students for joining the apprenticeship programs. One such program was organized by Hemvati Nandan Bahuguna(HNB) Garhwal University on 14th Jan 2022,

In Quarter 3 of FY 21-22, LSSSDC continued its Apprentice facilitation to various Industries to join and scale up apprentice engagement. As a result and significantly all Biocon group companies have now been on-boarded for engaging apprentices in both manufacturing and sales. As a result of similar support one of the largest Drug Distributor Companies in Tripura has started engaging apprentices for Store Assistant-Life Sciences. It is the first company in Tripura to participate in NAPS scheme to create pool of employable skill resources in the sector.


After success of LSSSDC's first Professional Development Program module for up-skilling/reskilling of Machine Operators with over 2400 user licenses sold, for which the credit goes largely to our team member Shivi, LSSSDC launched another two programs namely 360 Degree GMP for Manufacturing Assistants and 360 Degree GMP for Packaging Assistants—in partnership with GIZ. These two programs intend to cover 360 Degree Aspects of Good Manufacturing Practices required for these two job roles.

Reputed organizations such as Cipla Limited, Sun Pharmaceutical Industries Limited and Syngene International Ltd amongst others have already enrolled their workforce in these two programs and many others are considering this module.



NEWS UPDATE: LSSSDC INVITES AND ENGAGES INDUSTRY FOR COLLABORATION WITH ITI ECOSYSTEM AND UPGRADE ITI/ NSTI FOR PHARMA FOCUSED SKILLING AND UPSKILLING

In a recent initiative under MSDE's directive, LSSSDC has started working to collaborate with ITI Ecosystem. Council has reached out to Industry for collaborating in upgradation of ITIs / NSTIs near its manufacturing units under CSR funding. Focus is utilising ITIs in skilling of students for the high demand qualifications at appropriate level in the sector like Machine Operator, Manufacturing & Packaging Assistants, Maintenance Assistants etc. Such upgraded ITIs can then also be used by Industry for upskilling of their manufacturing workforce on engineering and maintenance skill sets.

At the very start, Torrent HR leadership team is working with LSSSDC to evaluate the adoption and upgradation of ITIs in Gujarat State.

In parallel LSSSDC is working with Saurabh Chemicals Limited (SCL), an API manufacturer in Derabassi Belt in Punjab, to adopt two ITIs near its plants and skilling of few plot batches under CSR funding.

AN UPDATE ON ASSESSMENT, TTT, TOA AND TOMT

LSSSDC continues building it's strong ecosystem of certified trainers. One open batch of online Training of Trainer program was conducted. 18 Trainers participated for 05 different QPs. With this program completion, the total certified Trainer count for LSSSDC in Life Sciences occupations is 629.

To facilitate Skill Vigyan Program of Odisha State Sciences and Technology Council, a 'Train the Trainer' program was conducted for eminent professors from Odisha for Lab technician - Research and Quality Control: Wet Lab and Microbiologist-Quality Control in Bio-Agri segment.

NEWS UPDATE: NSQC/ NCVET APPROVES FOUR (4) REVISED AND RATIONALIZED QUALIFICATIONS IN LIFE SCIENCES SECTOR

LSSSDC has submitted its four (4) rationalized and revised qualifications post industry validation with NCVET, National Vocational Education Regulatory Body under Ministry of Skill Development and Entrepreneurship. All the four qualifications were approved in the 17th NSQC Meeting held virtually by NCVET on 31st March 2022.




