Quarter 3 saw Sandoz, a globally recognised manufacturing organisation under the OPPI banner, being on boarded for Apprenticeship. We are truly excited to having Sandoz as an Industry Partner, and look forward to adding value to their Talent and HR space.

Team LSSSDC had a series of meetings with CBSE with view to integrating school curriculum with school focused Life Sciences modules. Our focus is to keep schools students equipped with awarness, knowledge and foundation skills to enable them to take up career in Life Sciences sector and enhance their carrer opportunities and future prospects. Once this integration is accomplished, LSSSDC would have closed the loop both at school and college (PCI) level with Industry.

The Council continued to strenthen its foundation blocks—through rationalisation of key qualification packs and further TTT/TOA programs— and its bonds with both Industry and Academia, with various events and inititiatives. Noteworthy were emeetings with Sun Pharma, which MD, Sri Dilip Shanghvi personally attended together with other top management, and emeetings with Torrent and Biocon. These meetings will give a fillip to our growing partnership with each of these majors.

The quarter also witnessed the Council jumping up two places to secure the 4th rank amongst all Skill Council's, for the year 19/20. LSSSDC also received recognition from Karnatak State (the hub for Bio Pharma) by featuring in handbook on best governance practises 2020/21. Finally, the Council's work on Standards, Curriculum and Content was applauded by NCVET as serving as template for rest of skilling eco system. Team LSSSDC can take strength and pride from these accolades, as it looks to exploring the plethora of opprtunities and surmounting the challenges ahead.

COVER STORY: MOU SIGN OFF BY LSSSDC AND PHARMACY COUNCIL OF INDIA WITH 150 UNIVERSITIES AND COLLEGE FOR B. PHARMA

On 4th Dec 2021, Life Sciences SSC & Pharmacy Council of India (PCI) in association with NCVET & NSDC organised MoU Sign off event (Virtual) for implementation of LSSSDC vocational Qualifications as an elective in B. Pharma VIII Semester.

To recap, the two key features of 'Skill Advancement Program', in Partnership with PCI are:

B. Pharma curriculum in its 8th semester offers LSSSDC developed, Industry validated and NSQFaligned skilling modules as electives, with score to count towards the final B. Pharma score of candidates.

Candidates would be encouraged to take on Apprenticeship opportunities in their vertical of interest

Whilst the initiative is currently focusing on B. Pharma stream, it will gradually cover D. Pharma and M. Pharma, the other favoured streams for Industry workforce in the sector, as well. The initiative is also in line with the NEP put out by GOI.

Around 50 colleges under PCI had already signed MOUs with LSSSDC for implementing the above. The virtual event on December 4, led to a further 100 PCI colleges signing MOUs with LSSSDC, with a further almost 50 registering intentions to sign.

The event was graced by Chairman, NCVET Dr Nirmaljeet Singh kalsi, Sri Vedmani, Acting CEO, NSDC, and Mr Sudarshan Jain, Chairman Elect, LSSSDC and DG, India Pharmaceutical Alliance or IPA (representing top 25 Pharma companies in India). Over the course of next 2-3 years, LSSSDC expects all 1800 PCI colleges offering B. Pharma to be fully integrated with it and offering NSQF aligned modules. APPRENTICESHIP CONTTRACTS CROSS 10K MILESTONE: SUPPORT TO INDUSTRY & OTHER INSTITUTIONS

More than 10,000 apprentice contracts have been generated till 31 December 2021, as against 10,000 in the full year 2020/21. Every month over 1,000 contracts are being triggered. In total we have crossed 28,000 contracts since inception. Top 5 states are Gujarat, Telangana, Maharashtra, Goa and Tamil Naidu.



On 4 October 2021, BTTI-ITI, Baddi, organized an apprenticeship fair along with DGT in the august presence of Chief Guest- Shri Guleria ji Advisor BBNIA and Shri Lalit Kumar ji from DTE SNG.

During this pharma and other industries having presence in Baddi participated and selected candidates on the spot for apprenticeship training in their respective organizations.

BTTI, LSSSDC Pharma is a dedicated centre for basic training provider in alternative job roles like Machine operator, Manufacturing assistant, Fitter mechanical and other DGT designated trades where small and medium pharma enterprises can get benefits of training their apprentice trainees before sending them on job training.

Apprenticeship Facilitation Program launched by LSSSDC, to provide end to end support and solutions to Industry, including support in mobilization of apprentices, helping firms in filing claims and reimbursement, and follow up to get quarterly reimbursements, is gradually catching on. Awareness and follow up meetings are being conducted with Industry Partners.

COVER STORY: LSSSDC SECURES 4TH POSITION IN RANKING OF SSC




